### Sales Tax:

All sales will be transacted directly between the vendor and the buyer. Vendors are responsible for collecting **8% sales tax** on each sale. Vendors are responsible for reporting their taxable income to the State of Idaho and City of Ketchum. Forms will be provided at the event for each. Even if you have a permanent tax ID #, you will be required to fill out the form. Please have a copy of your tax ID # on the premises. To apply for a temporary sales tax #, please call the Idaho State Tax Commission at 208-334-7660, or you can apply using the form. It's quick and easy to do!
